NOTIFICATION

Rules for open competitive examination to be conducted by the Sikkim Public Service Commission for selection of candidates for appointment to the post of College Librarian in various Sikkim Government Colleges is hereby published for general information:

- 1. The number of vacancies to be filled up will be specified in the advertisement notice issued by the Sikkim Public service Commission.
- 2. An interview will be conducted by the Sikkim Public Service Commission for selecting candidates for these posts.
- 3. The date and the place of the interview will be fixed by the Sikkim Public Service Commission.
- 4. A candidate must pay fees as may be prescribed by the Commission.
- A candidate who is or has been declared by the commission to be guilty of any attempt
 on his part to obtain support for his/her candidature by any means shall render
 himself/herself liable to be disqualified for admission to the competitive examination.
- 6. A candidate who is or has been declared by the Commission guilty of impersonation or of submitting false and fabricated documents which have been tampered with or making statement which are incorrect or false or suppressing material information or otherwise resorting to any other irregular or improper means for obtaining admission to the examination hall or of using or of attempting to use unfair means in the examination hall may, in addition to rendering himself/herself liable to a criminal prosecution be debarred:
 - (a) By the Commission permanently or for specified period for admission in to any examination or appearing at any interview held by the Commission for selection of candidates.
 - (b) By the State Government from any employment under them.
- 7. After the interview, the names of the successful candidates will be arranged by the Commission in order of merit as disclosed by the aggregate marks finally awarded to each candidate. Candidates shall be considered for appointment to the available vacancies in the order in which their names appear in the list.

- The terms and manner or announcement of results of the examination shall lie with the Commission. The Commission will not enter into any correspondence with any candidates regarding result.
- Condition of eligibility for appearing at the competitive examination have been indicated in the Appendix-I
- 10. Candidates already in Government service or in Government owned undertaking or similar organization whether in permanent or temporary capacity or as work charge employee shall be required to submit their application along with the 'No Objection Certificate' from their employers.
- 11. Success in the examination confers no right to appointment unless Government is satisfied after such enquiry as may be considered necessary that a candidate having regard to his character and antecedents is suitable in all respects for appointment.
- 12. A candidate must be in good mental and physical health and free from any physical defect likely to interfere with the discharge of his duties as a Librarian of an Institute. A candidate who (after such medical examination as may be prescribed by the Competent Authority) is found not to satisfy these requirements will not be appointed.
- 13. No travelling and daily allowances will be paid for the journey performed in connection with the interview and medical examination.
- 14. All other matters not specified or for which no provision has been made in these rules shall be regulated by rules and orders applicable to the service to which recruitment is being made.
- 15. During the period of Probation/Apprenticeship/Training, their pay shall be governed by Notification No.489/GEN/DOP date 31.10.2011 for initial period of one year.
