The Sikkim Public Service Commission has fixed the date for the 1st stage of Sikkim State Civil Service 2017 – Preliminary Examination for filling up of 12 (twelve) posts in the junior grade in PB-2 of Rs. 9300-34800 plus grade pay of Rs. 5000/- under Government of Sikkim as per details given below:

The admit cards for the same may be collected from 20.03.2017 to 07.04.2017 from the office of the SPSC, Old Tourism Complex, M.G Marg on all working days between 11 AM to 4PM. After the scheduled dates, no admit cards shall be issued.

Admission to all the stages of examination for which candidates are admitted by the Commission viz., Prelims, Mains and Interview/Viva-Voce will be purely provisional, subject to their satisfying the prescribed eligibility conditions. It is mandatory for the examinees to appear in both the papers for the purpose of evaluation. The examinee shall be disqualified in case he/she does not appear in both the papers. This examination is meant for screening the candidates for the Mains Examination and the marks obtained will not be taken into account to determine their final ranking.

IF AT ANY SUBSEQUENT STAGE OR AT THE TIME OF INTERVIEW ANY INFORMATION GIVEN BY THEM OR ANY CLAIM MADE BY THEM IN THEIR APPLICATION IS FOUND TO BE FALSE, THEIR CANDIDATURE WILL BE REJECTED AND THEY SHALL BE DEBARRED EITHER PERMANENTLY OR FOR A SPECIFIED PERIOD BY THE COMMISSION FROM ANY EXAMINATIONS HELD BY THEM IN THE FUTURE.

Successful candidates who clear the Preliminary Examination are required to submit the attested copies of the requisite documents for scrutiny to become eligible for appearing in the Written Mains Examination. During the scrutiny process, if any candidate is unable to provide supporting original documents, their candidature will be cancelled immediately and the next candidate in the merit list of the Preliminary Examination will be called for the next stage of the selection process.
