Applications are invited from the eligible local candidates for filling up of 02 (two) posts of **Photographer** on temporary regular basis in PB-2 of Rs. 9300-34800 plus Grade Pay of Rs. 3800/- through direct recruitment under Information & Public Relations Department, Government of Sikkim.

However, during the period of Probation/Apprenticeship/Training, pay shall be governed by Notification No: 489/GEN/DOP dated: 31.10.2011.

Those candidates who had applied for the post of Photographer in the Sikkim Public Service Commission as per our earlier advertisement No. 02/SPSC/2014 dated: 04.03.2014, need not apply again. However, these candidates who had already applied should confirm their candidature with the Commission.

**CONDITIONS OF ELIGIBILITY:**

**1. Minimum Educational Qualification:**

(i) 03 (three) years diploma in Photography/ Cinematography/ Photography and Cinematography from a recognized institution by All India Council of Technical Education (AICTE) or 03(three) years Degree in Photography/ Cinematography/ Photography and Cinematography from recognized University.

**OR**

(ii) Graduate in any discipline from recognized University with minimum 02(two) years Post Graduate Degree in Photography/ Cinematography/ Photography and Cinematography or with minimum 02(two) years Post Graduate Diploma in Photography / Cinematography/ Photography and Cinematography from an institution recognized by AICTE/University.

(iii) In accordance with Notification No: 44/GEN/DOP dt: 27.10.2015 candidates who are in the final/semester of the prescribed course shall be accepted provided such candidates have cleared all the previous semesters at the time of submission of applications and subject to submission of the final year results on or before the date specified by the Sikkim Public Service Commission before interview. Non-submission of the proof of essential educational qualification by prescribed date shall make the application of such candidates liable to be rejected without assigning any reason thereof.

**2. Other requisites**

- : (a) Should have experience of at least 02 (two) years in a reputed studio or institute.
- (b) Diploma/Certificate in Computer Application from a reputed Institute.
- (c) Candidate must be in possession of either Sikkim Subject Certificate or Identification Certificate issued by the competent authority under relevant orders of the State Government.
- (d) Should have valid Local Employment Card.

- (e) Should have knowledge of any of the State Languages viz Nepali/Sikkimese/Bhutia/Lepcha/Limboo.
- (f) Should be conversant with the customs and usages of Sikkim.

- 3. Duties of the post** :
- (a) To assist the Photo Officer.
  - (b) To take photographs of government functions throughout the state.
  - (c) Designing & Layout of print advertisement and print production and publication including hoardings and banners.

- 4. Age** : Should have attained the age of 18 years, but should not have exceeded 30 years as on **31.07.2016**.

The upper age limit for the candidates belonging to Bhutia - Lepcha, Scheduled Caste, Scheduled Tribes (Limboo - Tamang), Primitive Tribe is 35 years, Other Backward Classes (Central List) is 34 years and Other Backward Classes (State List) is 33 vide Notification No. M(135)/12/GEN/DOP dated 27<sup>th</sup> May, 2015.

The upper age limit is relaxed upto 50 (fifty) years for the purpose of recruitment in Government service under the State of Sikkim in respect of the persons working in Group 'B', 'C', & 'D' category on temporary basis (muster Roll/Adhoc /Substitute / Contract/ Workcharged etc.) under the State/Central Government Departments, Public Sector Undertakings, Private Educational Institutes viz. Sikkim Manipal University, Sikkim University, Vinayak Mission University established in the State, Private Companies established in Sikkim under Companies Act, 1956 and in various State/Central Government projects / programmes under implementation in the State vide Notification No. M(3)/Part-III/28/GEN/DOP dated 4<sup>th</sup> August, 2015.

**6.** Complete application form accompanied by (1) attested copies of Class X Mark sheets/Certificate containing Date of Birth. (2) Diploma Mark Sheet/ Diploma Certificate awarded by the Board/University (3) Valid Local Employment Card issued by the appropriate authority of the Government of Sikkim, (4) Certificate of Identification/Sikkim Subject Certificate (5) Category Certificate and (6) No Objection Certificate from the Appointing Authority/ Head of Department in case of employed candidate, should reach the Secretary, Sikkim Public Service Commission, Old Tourism Office, M.G.Marg, Gangtok by hand or by post on or before **14.09.2016**

***However the candidate should ensure that they are qualified on the date of interview in all respect. Candidate will not be intimated by the SPSC for any discrepancy or disqualification at personal level. However, those candidates whose forms are found to be incomplete in any manner will be summarily rejected, so all candidates are advised to ensure that they are qualified for the post.***

The form should be filled up by the candidate himself/herself and submitted in the office of the Sikkim Public Service Commission on any working day between 10:30 am. to 03:30 pm along with **original Bank Receipt of State Bank of Sikkim, for Rs. 150/- credited to**

**'0051-SPSC'**. The amount once deposited shall not be refunded or adjusted against any other purpose.

The complete filled in application form should reach the Secretary, Sikkim Public Service Commission, Old Tourism Office, M. G. Marg, Gangtok by hand or by post **on or before 14.09.2016 at 03.00 pm.**

No application submitted after **03.00 pm. on 14.09.2016** will be accepted. SPSC will not be responsible for late receipt of application due to postal delay or otherwise.

One stamp size photograph should be affixed on the application form in the space provided and **two identical stamp size photographs** with the candidates name on the back side of the photograph should be submitted along with the application form.

**Before filling the application form, candidate should go through the advertisement and accordingly they should fill the forms. Those claiming reservation should categorically specify the categories to which he/she belongs in the box provided in the application form.**

Those candidates who qualify in the written examination will be called for interview in the ratio of 1:3 as fixed by the Notification. No TA/DA is admissible for attending the examination/Interview.

**Admission at all the stages of examination for which candidates are admitted by the Commission viz. Main (written) Examination and Interview Test will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission without notice.**

**The Commission will not entertain any application on review or RTI/Correspondence till the entire process of recruitment is complete.**


