The amount so deposited shall not be refunded or adjusted against any other purpose.

Complete application form accompanied by (1) Attested copies of Class X & XII Mark sheets/Certificate containing Date of Birth. (2) Degree Mark Sheet and Degree Certificate in Law awarded by the University (3) Valid Local Employment Card issued by the competent authority of the Government of Sikkim, (4) Valid Certificate of Identification/Sikkim Subject Certificate and (5) Valid category certificate for BL/ST/MBC/OBC/SC certificate issued by the competent authority of the Government of Sikkim (6) No Objection Certificate from the Appointing Authority/ Head of Department in case of employed candidate.

The complete application form should reach the Secretary, Sikkim Public Service Commission, Old West Point School complex, Near Police Headquarter, Gangtok by hand or by post on or before 03:00 p.m. on <u>07.04.2014</u>. Admission at all the stages of examination for which candidates are admitted by the Commission viz: Main (written) Examination and Interview Test will be purely provisional and is subject to their satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission.
