Applications are invited from the eligible local candidates for filling up of 16 (sixteen) posts of Village Level Worker (VLW) on temporary regular basis in PB-1 of ₹ 5200-20200 plus Grade Pay of ₹ 3000/- under Food Security and Agriculture Development Department, Government of Sikkim, through Direct Recruitment.

However, during the period of Probation/Apprenticeship/Training, pay shall be governed by Notification No: 489/GEN/DOP dated: 31.10.2011.

CONDITIONS OF ELIGIBILITY:

1. Minimum Educational Qualification:

- (i) Class XII passed with Bio-Science or Class XII passed with subject of Agriculture/Horticulture under Vocational stream from a recognized Board. The successful candidates have to undergo Diploma Course in Agriculture/Horticulture Science within 03(three) years of appointment. Degree holders of Agriculture/Horticulture need not undergo the Diploma Course.
- In accordance with Notification No: 44/GEN/DOP (ii) 27.10.2015 candidates who are in the final/semester of the prescribed course shall be accepted provided such candidates have cleared all the previous semesters at the time of submission of applications and subject to submission of the final year results on or before the date specified by the Sikkim Public Service Commission before interview. Non-submission of the proof of essential educational qualification by prescribed date shall make the application of such candidates liable to be rejected without assigning any reason thereof.

2. Other requisites

- : (a) Candidate must be in possession of either Sikkim Subject Certificate or Identification Certificate issued by the competent authority under relevant orders of the State Government.
 - (b) Should have knowledge of any of the State Languages viz Nepali/Sikkimese/Bhutia/Lepcha /Limboo.
 - (c) Should have valid Local Employment Card.
 - (d) Should be conversant with the customs and usages of Sikkim.

3. Duties of the post

:

Each VLW has to implement Agriculture & Horticulture policies of the Government in the grassroots.

4. Age

Should have attained the age of 18 to 30 years, but should not have exceeded 30 years as on 01/05/2016.

The upper age limit for the candidates belonging to Bhutia - Lepcha, Scheduled Caste, Scheduled Tribes (Limboo - Tamang), Primitive Tribe is 35 years, Other Backward Classes (Central List) is 34 years and Other Backward Classes (State List) is 33 years vide Notification No. M(135)/12/GEN/DOP dated 27th May, 2015. In the case of Regular Government Servant not more than 40 (forty) years.

50 (fifty) years in respect of temporary employees Roll/Adhoc /Substitute Contract/ (Muster / Workcharged State/Central etc.) under the Government Departments, Public Sector Undertakings, Private Educational Institutes viz. Sikkim Manipal University, Sikkim University, Vinayak Mission University established in the State, Private Companies established in Sikkim under Companies Act, 1956 and in various State/Central Government projects programmes under implementation in the State vide Notification No: M(3)/Part-III/28/GEN/DOP dated 4th August, 2015.

Those candidates who had applied for the post of Village Level Worker in the Food Security & Agriculture Development Department as per the Employment Notice No: 569/FS&AD dated: 23.03.2015 need not apply again. But those candidates who had already applied should confirm their candidature with the Commission.

Fresh Candidates should submit a copy of their documents duly attested by the competent authority as prescribed in the application form (Sl. No. 17 *Details of Certificate) to SPSC for scrutiny. However, those candidates whose forms are found to be incomplete in any manner will be summarily rejected, so all candidates are advised to ensure that they are qualified for the post.

Application form and syllabus can be downloaded from www.spscskm.gov.in. The form should be filled up by the candidate himself/herself and submitted in the office of the Sikkim Public Service Commission on any working day between 10:30 am. to 03:30 pm along with original Bank Receipt of State Bank of Sikkim, for Rs. 150/- credited to '0051-SPSC'. The amount once deposited shall not be refunded or adjusted against any other purpose.

The complete filled in application form should reach the Secretary, Sikkim Public Service Commission, Old Tourism Office, M. G. Marg, Gangtok by hand or by post on or before 03.00 pm. on 13.06.2016.

No application submitted after 03.00 pm. on 13.06.2016 will be accepted. SPSC will not be responsible for late receipt of application due to postal delay or otherwise. A DROP BOX has been provided for the convenience of the candidates in the SPSC Office.

One stamp size photograph should be affixed on the application form in the space provided and two identical stamp size photographs with the candidates name on the back side of the photograph should be submitted along with the application form.

Before filling the application form, candidate should go through the advertisement and accordingly they should fill the forms. Those claiming reservation should categorically specify the categories to which he/she belongs in the box provided in the application form. No TA/DA is admissible for attending the examination/Interview.

Admission at all the stages of examination for which candidates are admitted by the Commission viz. Main (written) Examination and Interview Test will be purely provisional and is subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfill any of the eligibility conditions, their candidature for the post will be cancelled by the Commission without notice.

The Commission will not entertain any application on review or RTI/Correspondence till the entire process of recruitment is complete.
