It is further informed to all concerned applicants that the Classroom Demonstration (through Video Conference)/Viva Voce and Interview will be held on 10<sup>th</sup> of November 2020, at Sikkim Public Service Commission from 10:00 am onwards.

Eligible candidates whose names appear in the list above are required to prepare a presentation on any three topics of his/her choice from their subject in Post-Graduation out of which the candidate will be required to give 20 (twenty) minutes classroom demonstration/lecture on any **one** topic selected by the Subject Expert. Classroom Demonstration is to be done on White Board only which will be followed by 10 (ten) minutes Viva Voce with the subject expert.

The call letters to the shortlisted candidates will be issued on the day of Interview during registration hours for which candidates need to furnish photo ID proof.

Candidates are advised to report with originals of their credentials on the said date.

Admission to all the stages of examination for which candidates are admitted by the Commission viz; Class Room Demonstration and Viva Voce will be purely provisional, subject to their satisfying the prescribed eligibility conditions. If on verification at any point of time before or after the Class Room Demonstration and Viva Voce, it is found that they do not fulfil any of the eligibility conditions; their candidature for the examination/post will be cancelled by the Commission.
