- 2. The call letters to the shortlisted candidates will be issued on the day of the Classroom Demonstration/Interview during registration hours. Candidates are required to furnish photo ID proof.
- 3. Candidate are required to prepare a presentation on any three topics of his/her choice from their subject in Post-Graduation, out of which the candidate will be required to give 20 (twenty) minutes classroom demonstration/lecture on any one topic selected by the Subject Expert.
- 4. Classroom Demonstration is to be done on White Board; no Power Point Presentation is allowed.
- 5. Candidates are advised to come along with originals of all their credentials they have submitted.
- 6. Admission to all the stages of examination for which candidates are admitted by the Commission viz; Class Room Demonstration and Viva Voce will be purely provisional, subject to their satisfying the prescribed eligibility conditions. If on verification at any point of time before or after the Class Room Demonstration and Viva Voce, it is found that they do not fulfil any of the eligibility conditions; their candidature for the examination/post will be cancelled by the Commission.
