(II) Education Qualification:

- 1. Masters Degree in respective subject with minimum of 55% marks.
- 2. M.Ed.(with minimum of 55% of marks) or Ph.D/NET/ SLET & B.Ed. (with minimum of 55% of marks)

(III) Eligibility Criteria:

(a) PGTs/GTs of Government School under State Government of Sikkim with minimum of 08 (eight) years of teaching experience in regular service as PGT/GT.

or

(b) Lecturers of DIETs with minimum of 05 years of continuous teaching experience in regular service.

or

- (c) PGTs/GTs working in SCERT/DIETs/B.Ed. College on deputation can also apply provided, if they have required teaching school experience of 08 years.
- (IV) Applicants should ensure that they are eligible and qualified on the date of application and their forms are complete in all respect.
- (V) Application form should be supported by the following documents.
 - (i) NOC from concerned Appointing Authority duly authenticated the No. of years of service rendered in the present post (in original).
